Paris-Hoyte Presentation:

This presentation will offer five learning objectives specific to navigating bias in the legal system using an Ethical Standards Framework. These five objectives focus on building an ethical and practical foundation to navigate bias responsibly and advocate effectively as practitioners.

- 1. **Develop Self-Awareness in Professional Practice**: Participants will reflect on and recognize their own biases and assumptions, understanding how self-awareness is foundational to ethical forensic social work practice and a critical step in providing fair and unbiased decision-making.
- 2. Enhance Cultural Competency and Sensitivity: Participants will learn to equip themselves with skills and knowledge to engage in culturally competent practice, allowing them to respect and understand diverse backgrounds and perspectives and avoid reinforcing stereotypes in their assessments and interventions.
- 3. **Apply Ethical Decision-Making Models**: Participants will be introduced to an ethical decisionmaking framework that teaches them to navigate complex situations involving potential biases, supporting them in making fair, balanced, and ethically sound decisions in legal settings.
- 4. **Promote Client Empowerment and Transparency**: Participants will learn about traumainformed methods, which involve the client's active engagement in the legal process, fostering transparency and empowering their clients to understand and participate in decisions that affect their lives while adhering to ethical and professional standards.
- 5. Advocate for Equity, Fairness, and Systemic Change: Participants will learn about engagement and how to advocate for fairness and equity within the legal system, emphasizing the role of forensic social workers in addressing systemic inequalities and supporting policy changes that promote justice at both individual and institutional levels.
